2. The Advertisement inviting applications for admission under Institutional (Management) quota will be displayed on MMIT website as per the following schedule. The details of the Courses offered are also given below. The Candidates shall apply and register by submitting application form (available in the office) along with photocopies of the required documents at MMIT Office.

After verification of all required documents, the inter-se-merit list of the candidates to be filled in at the institution level in the Institutional Quota, along with the vacant seats after CAP (Page No. 79 of CET Brochure) will be displayed on the notice board and the same will also be published on MMIT website
4. The candidates who are given provisional allotment shall report to the Institute as per the schedule given below. If any candidate fails to report as per the schedule and admission procedure, the seat will be treated as vacant and the same will be filled in during the SPOT Round(s) along with the remaining vacant seats.
5. The candidates shall report for the SPOT Round(s) as per the schedule. If any candidate fails to report as per his/her timeslot, he/she will not be permitted to participate for the SPOT round.
