Guidelines for SPOT ROUND Direct Second Year Undergraduate (B.E.) admissions against vacant seats after ACAP Round and probable cancellation, if any for A.Y. 2025-26.

- 1. The Candidates shall register by submitting the application form in the institute along with the photocopies of the required documents, as per the above schedule.
- 2. The round will be conducted purely on Merit basis as per the guidelines of eligibility published by State CET Cell, Government of Maharashtra.
- 3. Candidates must bring a signed copy of Acknowledgement received by Scrutiny Centre.
- 4. If the candidate accepts the seat in the SPOT Round, he / she has to complete the admission process by payment of applicable fees and submission of documents immediately during the process on the same day. If any candidate has secured his / her admission in another institute, then he / she must carry the admission letter in original and one set of self-attested documents.
- 5. Candidates must report strictly as per the reporting time. Late reporting is not permitted under any circumstances and any reason/discussion/claim will not be entertained in this case.
- 6. <u>After conduction of the SPOT ROUND, if the vacancies still persist, subsequent spot rounds will be conducted to fulfil the vacancies.</u>
