Guidelines for SPOT Round

- 1. SPOT Round for seats vacant after ACAP Round, probable cancellation, SPOT Rounds, if any for A.Y. 2025-26 for the eligible aspiring Maharashtra State Candidature candidates (MS) will be conducted in MMIT campus on **09/09/2025** as per the schedule given below and it will be purely on Merit basis as per the guidelines of eligibility published by State CET Cell, Government of Maharashtra. Priority in allotment will be given to the candidates having higher SML number.
- 2. Candidates must bring a signed copy of Acknowledgement received by Scrutiny Centre.
- 3. If the candidate accepts the seat in the SPOT Round, he / she has to complete the admission process by payment of fees and submission of documents immediately.
- 4. The candidate must carry all the required documents in original, one set of photocopies and registered mobile handset. If any candidate has secured his / her admission in another institute, then he / she must carry the admission letter in original and one set of self-attested documents.
- 5. Candidates must report strictly as per the reporting time. Late reporting is not permitted under any circumstances, and any reason/discussion/claim will not be entertained in this case.
- 6. After the the first round, if vacancies still persist, subsequent spot rounds will be conducted to fill the vacancies.
- 7. The schedule displayed above is provisional and may change under unavoidable circumstances. The revised schedule, if any, will be notified on MMIT website.
- 8. Candidates belonging to the Supernumerary type can not participate in Spot rounds.
