**Guidelines for SPOT ROUND First Year Undergraduate (B.E.) admissions against vacant seats after ACAP Round, Institutional Level Rounds and probable cancellation, if any for A.Y. 2025-26.**

1. The Candidates shall register by submitting the application form in online mode (Google Form) or offline (Physical mode) along with the photocopies of the required documents, as per the above schedule.
2. The round will be conducted purely on Merit basis as per the guidelines of eligibility published by State CET Cell, Government of Maharashtra.
3. Candidates must bring a signed copy of Acknowledgement received by Scrutiny Centre.
4. If the candidate accepts the seat in the SPOT Round, he / she has to complete the admission process by payment of applicable fees and submission of documents immediately during the process on the same day. If any candidate has secured his / her admission in another institute, then he / she must carry the admission letter in original and one set of self-attested documents.
5. Candidates must report strictly as per the reporting time. Late reporting is not permitted under any circumstances and any reason/discussion/claim will not be entertained in this case.
6. After conduction of the SPOT ROUND 2, if the vacancies still persist, subsequent spot rounds will be conducted to fulfil the vacancies.
7. The schedule displayed above is provisional and may change under unavoidable circumstances. The revised schedule, if any, will be notified on MMIT website.
