Guidelines for First Year Undergraduate (B.E.) admissions against vacant seats after CAP Round (ACAP), Institutional Level Rounds (IL), SPOT Rounds for A.Y. 2025-26.

- 1. The vacancies at the Institute Level, Against CAP, Spot Rounds, and Institute Level are as mentioned above and may be dynamic in nature. There may be seats available that are not shown in the vacant seat matrix due to probable cancellations. Please refer LINK FOR VACANCIES for exact vacancies.
- 2. Three separate merit lists based on MH-CET Percentile (2025)-MS Candidature, JEE (Main) Score (2025) All India candidature and Diploma Final Year Percentage will be published on the institute website. (Merit lists will be prepared amongst the candidates applied to the institute through Google Form / applied on CET Cell portal).
- 3. Seats under Institutional quota will be filled in based on MH-CET Percentile (2025). Preference shall be given to the Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of Inter-Se-Merit.
- 4. The Institute Level Admission Round, Against CAP Round and Additional Rounds (SPOT) will be conducted as per the above schedule.
- 5. All the above admissions will be carried out as per Rule No. 13 mentioned in the Information Brochure for the academic year 2025–26, published by the State Common Entrance Test Cell, Maharashtra State, in a transparent manner and purely on a merit basis.
- 6. The advertisement inviting applications for admission under the Against CAP seats will be displayed on the MMIT website as per the above schedule.
- 7. Candidates shall apply and register by submitting the Google Form (https://forms.gle/4f1RGHW6fmMPDrEdA) and by paying the non-refundable processing fees of Rs. 1,000/- through the QR code. Submission of the Google Form does not confirm admission; it is only an application. Candidates who wish to participate in SPOT Rounds (after IL and ACAP Rounds) and have registered only at CET Cell portal, shall submit their interest by filling the same Google form and by paying an application fee of Rs. 1,000/-.
- 8. After verification of the attached documents, the inter-se merit list will be prepared by combining the list of candidates received from the CET Cell.
- 9. The merit list will be displayed on the institute's notice board and will also be published on the MMIT website as per the schedule.
- 10. If any CAP seat remains or becomes vacant after the CAP Rounds, it shall be filled by a candidate from the same category (if available) for which it was earmarked during the CAP.
- 11. Candidates will lose their claim to participate in the admission counselling process if they fail to produce all applicable original documents at the time of document verification during the counselling round. If a candidate has already taken admission elsewhere, he/she will be required to produce the original fee receipt and submit an undertaking stating that the original documents will be submitted within two working days from the date of reporting.
- 12. Candidates are advised to be present in the Counselling Hall and wait for their turn. If a candidate is unavailable when called, he/she may miss the chance of merit-based seat allotment, and the seat will be offered to the next candidate.
