Admission will be conducted strictly as per the eligibility criteria, rules and Information Brochure prescribed by the State CET Cell for A.Y. 2026–27.

2. ELIGIBILITY AND APPLICATION

Candidates seeking admission under Institute Level Seats and/or Against CAP (ACAP) Seats shall:

- Fulfil the eligibility criteria prescribed by the State CET Cell and Government of Maharashtra.
- Register on the State CET Cell portal and complete the prescribed document verification/e-Scrutiny or Physical Scrutiny process.
- Submit the prescribed online application form to the Institute.
- Pay the processing fee of ₹1,000/- at the time of submitting the application.
- Ensure that the application is complete. Only completed applications will be considered for preparation of the merit list.

3. ADMISSION PROCESS

Admissions to Institute Level and Against CAP (ACAP) seats will be conducted strictly on the basis of Inter-se Merit, as per the rules and norms prescribed by the State CET Cell.

Candidates admitted through these rounds shall pay the fees prescribed by the Fees Regulating Authority, Government of Maharashtra, for the respective category of seats, along with other applicable fees prescribed by SPPU and competent authorities.
